

Oceanside Neighborhood Association Meeting
Regular meeting, February 6, 2016
Oceanside Community Center

The meeting was called to order by Judson Randall, ONA President, at 10:05 AM.

The minutes from the previous meeting, December 5, 2015, were approved.

The Treasurer's Report shows no change in the ONA funds since December. The Jan. 31, 2016, treasurer's report is included at the end of these meeting notes.

First guest speaker was Mike Cohen, Director of the Tillamook Economic Development Council (EDC), and the Small Business Development Center (SBDC).

The EDC has small business Revolving Loan Fund for some local businesses, or start up businesses, that might be having a hard time qualifying at big banks. The EDC tries to be flexible.

Through the SBDC, Mike has workshops at TBCC, Tillamook Bay Community College, on Tuesday nights regarding small business topics. There also are workshops on local investing, and workshops on credit building for folks with bad credit.

Our 2nd speaker was Jennifer Purcell, candidate for Tillamook County Board of Commissioners, Mark Labhart's position. She lives in Bay City, and has been active in the County for decades. Jennifer introduced herself, discussed her priorities and answered questions.

Our 3rd speaker was Stevie Burden, candidate for the same Board of Commissioner's position. She is the mayor of Wheeler, and has also been active in the County for decades. She discussed her qualifications, priorities, and answered questions

Jud updated us on the progress of the new website design and improvements. The designer, Kelli Sussman, working on it said she thinks she's about a month out on this.

The Verizon Cell Tower Siting Application has been approved, so we're one step closer to getting better cell coverage in Oceanside. They aren't promising 100 percent service, but it should be better. Timeline for construction isn't known at this time.

In land use matters, the lot on Maxwell Mt. Road, about 4 down from the old House on the Hill Motel, was approved for a reduced setback by the County.
